

## **Illinois Prescription Monitoring Program - Automated Connection**





#### What is the PMP?

The Illinois Prescription Monitoring Program (PMP) collects information on controlled substance prescriptions dispensed in Illinois. The PMP website allows prescribers and dispensers to view a current or prospective patient's prescription history.

## What information does the PMP provide?

- Schedules II-V controlled substance prescription information
- ▲ Contains records for the last 12 months

#### Who submits prescription data?

Retail pharmacies dispensing in Illinois report on a daily basis (Public Act 099-0480).

#### **Preventing Abuse and Diversion**

The PMP can help prevent the misuse, abuse and diversion of controlled substance medications. The PMP can also help reduce the possibility of drug interactions as well as the possibility of duplicate therapies.

#### Introducing the PMP Automated Connection

The PMP Automated Connection is a service that allows prescribers and dispensers to automatically receive PMP data without having to log on to the PMP website.

## How does the PMP Automated Connection work?

A direct connection is built between the PMP and the requesting hospital, physician's office or pharmacy's Electronic Health Record (EHR) system. Before a patient is seen, PMP data is automatically sent to the facility's EHR system requiring minimal human interaction or none at all.

## Why use the PMP Automated Connection?

- ▲ Individual PMP login credentials are no longer required
- $\blacktriangle$  No more logging onto the PMP website
- Results are returned instantly
- ▲ Saves valuable clinical time
- ▲ Improves patient quality of care
